Brief Description of Proposal -

The Town of Pleasant Springs has requested the Dane County Sheriff's Office provide additional police service within the boun daries of Pleasant Springs Township, at a level above and beyond the basic level of police service currently provided. The Town of Pleasant Springs has agreed to compensate Dane County for the cost of assigning one certified sworn law enforcement officer, including necessary equipment and vehicle, to perform law enforcement services at approximately eight hours per month, effective 1/1/2016. The potential 2016 revenue is es timated at \$6,800.

Current Policy or Practice -

Contracts must be approved by the County Board and executed by the County Executive.

Impact of Adopting Proposal -

Providing law enforcement service to a community is an essential service that is costly, especially for small municipal governments. Purchasing policing service is less costly when compared to the cost of operating a municipal police department or establishing a new police department. The Dane County Sheriff's Office can provide a high level of cost effective service and policing efficiency to the community.
