9 The Alliant Energy Center uses outside help to assist with parking and traffic assistance
10 during events on campus. During the COVID-19 pandemic Contemporary Services
11 Corporation has been providing parking and traffic assistance for the drive through
12 testing and vaccination site being operated by Public Health Madison and Dane County
13 on the Alliant Energy Center campus. The Alliant Energy Center would like to continue
14 to utilize their services to host public events.

16 The Agreement is currently for a \$500,000 maximum contract cost. This contract has
17 been used to perform daily service on campus to support the COVID testing and
18 vaccine which was not predicted at the time the contract was created. Based on the
19 work performed thus far, the Alliant Energy Center wishes to increase the maximum
20 contract amount by \$500,000 through May 31, 2025 based on University of Wisconsin
21 Madison Contract #18-5059.

23 **NOW, THEREFORE BE IT RESOLVED**, that the contract for event parking and traffic
24 assistance with the Contemporary Services Corporation, 3100 Applegate Ct, Suite
25 #111, Madison, WI 53713 is hereby approved.

DANE COUNTY CONTRACT

ADDENDUM # 14270B

Revised 06/2021

THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and Contemporary Services Corporation (hereinafter, "Provider").

WITNESSETH:

WHEREAS Provider and County, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract #14270, have previously entered into a contractual relationship pursuant to which Provider provides parking, ticket taking, parking booth and other security services for events at the Alliant Energy Center, and

WHEREAS County and Provider wish to amend the Master Agreement in order to add funding to the contract.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as, an original, wet-inked manually executed document. Further, the Master Agreement and any amendment or addendum thereto, may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may at its option destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration or administrative proceeding whether or not the original is in existence and whether or not such reproduction was made by each party in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.
3. The amount of the contract is increased by \$500,000 to \$1,000,000.
