DCDHS – HAA DIVISION**

Policy Analysis Statement:

Brief Description of Proposal -
The Dane County Department of Human Services – Housing Access and Affordability Division (HAA) seeks to contract with Equitable Social Solutions, LLC to provide non-congregate shelter for people experiencing homelessness who are symptomatic/positive for COVID-19 or a close contact for a positive COVID-19 case. The contract term will be January 1, 2022 to June 30, 2022.

Major contracts require Board approval.

A major contract will be awarded to Equitable Social Solutions, LLC in the amount of \$1,049,346.
