Brief Description of Proposal -

Homeland Security (HS), Wisconsin Emergency Management (WEM), Department of Military Affairs (DMA), is providing grant funding of \$74,000 to support the Aligned Law Enforcement Response Team (ALERT) Hazard Devices Unit (HDU) equipment purchase, Grant Number 2021-HSW-02A-12689; funding of \$74,000 is available November 22, 2021 through November 25, 2022 and will provide for the purchase of two Med-Eng, EOD-10 bomb suits, helmets, batteries with charger kits, face shields, and foot protection.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

Impact of Adopting Proposal -

The purchase of this equipment is required because it provides hard and soft protection for bomb technicians when dealing dir ectly with hazardous and/or potentially explosive devices. Specifications of bomb suit and associated equipment, to bepurchased, is approved by N ABSCAB and the FBI. Bomb technicians wear a bomb suit while performing stressful tasks that require fine motor skills. Bomb suits are designed to protect against the characteristics of an explosive event that could result in human injury or death.
