AUTHORIZING AN AGREEMENT FOR GRANT FUNDING TO PURCHASE BREACHING TOOLS FOR THE SHERIFF'S OFFICE TACTICAL RESPONSE TEAM

Policy Analysis Statement:

Brief Description of Proposal -

The Homeland Security (HS) – Wisconsin Emergency Management (WEM), Department of Military Affairs (DMA) is providing \$8,000 grant funding to the Sheriff's Office for the purchase of breaching tools and equipment; Grant Number 2021-HSW-02A-12726, funding is available November 22, 2021 through July 29, 2022.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

Because of the tactical aspect of law enforcement special operations during conflict adversary conditions, special breaching tools are required to match the critical nature and demands of the operation to prevent injury and death to the public and law enforcement personnel.
