We rely on quarries around southern Wisconsin to provide rip-rap (6-24 inch stone) for all of our commercial stormwater BMP's around Wisconsin. A BMP is a "Best Management Practice" required by the DNR to keep our lakes and streams clean and to reduce flooding in our state. Stormwater BMP's are found on almost every commercial development and most large residential developments in Wisconsin. Most people see them as stormwater ponds or Dry basins. Almost all of these wet and dry basins use stone rip-rap as a functioning part of its success. This stone collects sediment and reduces erosion. It also functions as a way to reduce the temperature of water before it enters our streams. Without new stone quarries or the expansion of current stone quarries a vital tool used to keep our water resources clean would be in jeopardy.
