# ADDENDUM TO CONTRACT FOR SNOW REMOVAL SERVICES AT THE DANE COUNTY REGIONAL AIRPORT

Pursuant to Dane County Contract # 13853, CM Larsen, a sole proprietor with offices in Fitchburg, Wisconsin, provides snow removal services at the Dane County Regional Airport. The current term, as extended by Addendum No. 13853A, will expire on October 31, 2022. The County may extend the contract for up to two additional years under the same terms and conditions applicable to the original contract. The County and CM Larsen desire to extend the term of the agreement for the 2022-2023 and 2023-2024 winter seasons. The maximum cost for snow removal services to be provided by CM Larsen during each winter season is \$150,000. Airport staff has determined that approval of the requested addendum is in Dane County's best interest.

 **NOW, THEREFORE, BE IT RESOLVED** that the Dane County Executive and the Dane County Clerk are authorized to execute a second addendum to Dane County Contract No. 13853 under which CM Larsen will continue to provide snow removal services at the Dane County Regional Airport, as set forth above.

**THIS ADDENDUM**, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane ("County") and CM Larsen ("Provider").

#### WITNESSETH:

**WHEREAS** Provider and County, by a separate document, Dane County Contract # 13853 ("Master Agreement"), have previously entered into a contractual relationship pursuant to which Provider provides snow removal services at the Dane County Regional Airport, and

**WHEREAS** County and Provider wish to amend the Master Agreement in order to extend the term of the contract for the 2022-2023 and 2023-2024 winter seasons, as provided for in the Master Agreement.

**NOW, THEREFORE,** in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

- 1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
- 2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as, an original, wet-inked manually executed document. Further, the Master Agreement and any amendment or addendum thereto, may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may at its option destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration or administrative proceeding whether or not the original is in existence and whether or not such reproduction was made by each party in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.
- 3. The term of the contract is extended through October 31, 2024 to continue the program for two additional one-year terms. Pricing shall remain as set forth in Schedule B for Term 4 (11/1/2022 10/31/2023) and Term 5 (11/1/2023 10/31/2024).
