# Policy Analysis Statement:

#### Brief Description of Proposal -

Request approval to accept a monetary donation of \$5,248 from the Paul Rusk Legacy Fund to support Sheriff's Office, Dane County, social workers and educators, in recognizing the educational and self-betterment accomplishments of jail residents.

## Current Policy or Practice -

Acceptance of donations requires County Board approval.

#### Impact of Adopting Proposal -

Jail residents often participate in various rehabilitation programs that seek to improve the likelihood that they will lead a productive, crime-free life upon release. Dane County Jail residents that receive a High School diploma, earn a GED, complete parenting classes, or other similar self-betterment programs may complete an application explaining their accomplishments and receive a Kindle tablet with a case to take with them when released from the facility. Donation funding from the Paul Rusk Legacy Fund supports the jail resident self-betterment program.
