AN INITIAL RESOLUTION AUTHORIZING GENERAL OBLIGATION BONDS AND PROMISSORY NOTES

Policy Analysis Statement:

Brief Description of Proposal -
 This resolution authorizes the issuance of general obligation bonds and promissory notes to finance the various projects within the 2023 adopted capital budget. The sale of the debt for each project will be determined based on progress on the implementation of each project.

Current Policy or Practice -
 State statues require that county debt be authorized by a 3/4 vote of the County Board. The County Board considers a resolution such as this at the beginning of every fiscal year.

Impact of Adopting Proposal -
 Adoption of the resolution will allow departments to initiate work on the various projects or purchase equipment that was included in the budget.
