**AUTHORIZING AN AGREEMENT TO ACCEPT GRANT FUNDING FOR THE PURCHASE OF RESPIRATORS AND COMMUNICATION EQUIPMENT**

**Policy Analysis Statement:**

Brief Description of Proposal -

Request approval to accept grant funding for the purchase of respirators and communication for use by the Sheriff's Office Tactical Response Team (TRT).

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

The Dane County Sheriff's Office TRT requires air purifying respirators with enhanced digital radio communication connections and integrated digital voice protection devices to facilitate the sharing of information during high risk critical incidents and to protect against exposure to toxic atmospheres, harmful levels of particulates, chemicals, biological agents, and other contaminants.
