**Policy Analysis Statement:**

Brief Description of Proposal -  
This resolution accepts American Rescue Plan Act Home and Community-Based Services Grant funding from the Wisconsin Department of Health Services.

Current Policy or Practice -  
Budget changes require County Board approval.

Impact of Adopting Proposal -  
These funds will recreate a local, cross-system, inter-agency competitive integrated employment (CIE) transition team aimed at improving employment outcomes for young adults with intellectual and developmental disabilities with sustained need for job coaching and other long-term supports to ensuring young adults leave high school with paid employment earning minimum wage or more.
