NOTICE OF PUBLIC HEARING TO THE RESIDENTS OF DANE COUNTY, WISCONSIN

NOTICE IS HEREBY GIVEN that a representative of the Housing Authority of Dane County, Wisconsin (the "**Authority**") will hold a public hearing at 11:00 a.m. on August 28, 2015 in the offices of the Authority located at 2001 West Broadway, Suite 1, Monona, Wisconsin, regarding the proposed issuance by the Authority of revenue bonds pursuant to Sections 59.53(22) and 66.1201 to 66.1211 of the Wisconsin Statutes, as amended, in a maximum aggregate principal amount of \$6,730,000, on behalf of Dane County Housing Redevelopment, LLC, a Wisconsin limited liability company. The bonds would finance the acquisition and rehabilitation of three existing apartment projects for persons of low income containing an aggregate of approximately 54 units. The locations of the facilities to be financed are (i) 205 Danbury Court, DeForest, Wisconsin 53532 and currently known as the Spw DeForest Summerhill Apartments, (ii) 1601 Vernon Street, Stoughton, Wisconsin 53589 and currently known as the Park Vernon Apartments, and (iii) 506 West Verona Avenue, Verona, Wisconsin 53593 and currently known as the Park Verona Apartments. The initial owner of the facilities will be Dane County Housing Redevelopment, LLC.

The public hearing will be conducted in a manner that provides a reasonable opportunity to be heard for persons with differing views on both issuance of the bonds and the location and nature of the proposed facilities. Any person desiring to be heard on this matter is requested to attend the public hearing or send a representative. Written comments (not exceeding 250 words) to be considered at the hearing may be submitted to the Authority.

Comments made at the hearing are for the consideration of the County Board of Dane County, Wisconsin.
