AUTHORIZING AN AGREEMENT TO ACCEPT HIGHWAY SAFETY GRANT FUNDS FOR AN OWI TASK FORCE (03057)

Policy Analysis Statement:

Brief Description of Proposal -

The US Department of Transportation and Wisconsin Bureau of Transportation Safety is providing funding in the amount of \$90,1 08 to the Sheriff's Office for participation in a 2015/16 Operating While Intoxicated (OWI) Task Force, Grant Number FG -2016-DANE CO-03057. The project period begins 10/1/2015 and ends 9/30/16. OWI Task Force participating agencies will adopt a zero tolerance for impaired driving an d unrestrained occupants during all motor vehicle stops. The Sheriff's Office will administer the grant, collect data from OWI Task Force p articipating agencies and file reports, as required, by the State of Wisconsin.

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

Implementation of this project will save lives and make the roads safer for vehicles and pedestrians in Wisconsin. During 2014, in Wisconsin, alcohol-impaired driving was listed as a contributing factor in 4.1% of all crashes. 30.7% of all vehicle crash fatalities in 2014 were alcohol-related, resulting in 153 deaths. Alcohol-impaired driving is associated with other high-risk behaviors that increase the likelihood of a crash and of significant injury or death including speeding and failure to wear safety belts
