AMENDING CHAPTER 17 OF THE DANE COUNTY CODE OF ORDINANCES, UPDATING FLOOD INSURANCE RATE MAP PROVISIONS

The County Board of Supervisors of the County of Dane does ordain as follows:

ARTICLE 1. Unless otherwise expressly stated herein, all references to section and chapter numbers are to those of the Dane County Code of Ordinances.

ARTICLE 2. Section 17.05(2) is amended and renumbered to read as follows:

- (2) OFFICIAL MAPS & REVISIONS. The boundaries of all floodplain districts are designated as floodplains or A-Zones on the map listed below and the revisions in the Dane County Floodplain Appendix. Any change to the base flood elevations (BFE) in the Flood Insurance Study (FIS) or on the Flood Insurance Rate Map (FIRM) must be reviewed and approved by the DNR and FEMA before it is effective. No changes to regional flood elevations (RFEs) on non-FEMA maps shall be effective until approved by the DNR. This map and revisions are on file in the office of the Dane County Zoning Administrator. If more than one map or revision is referenced, the most restrictive information shall apply. OFFICIAL MAPS:

ARTICLE 3. Section 17.05(5) is amended to read as follows:

- (5) REMOVAL OF LANDS FROM FLOODPLAIN. Complaince Compliance with the provisions of this ordinance shall not be grounds for removing land from the floodplain unless it is filled at least two feet above the regional or base flood elevation, the fill is contiguous to land outside the floodplain, and the map is amended pursuant to s. 17.13.
- [EXPLANATION: This amendment updates Flood Insurance Rate Maps as approved by FEMA.]
