These funds are in addition to the original \$228,460 VOCA 10 grant for the period beginning October 1, 2015 and ending September 30, 2016 The original 11 grant is an ongoing grant and the expenditures and revenues were included in the 2016 budget. 12 13 The supplemental grant is expected to be available for continuation for 3 years. 14 The supplemental grant funds will be used to create a .70 FTE Crime Response 15 Specialist project position contingent on VOCA funding, necessary supplies, office equipment 16 and staff development. 17 18 NOW, THEREFORE, BE IT RESOLVED that the District Attorney's Office, Victim 19 Witness Unit is hereby authorized to accept \$70,771 from the Wisconsin Department of Justice. 20 21 BE IT FURTHER RESOLVED that the District Attorney's Office is authorized to create a 22 23 .70 FTE Crime Response Specialist position effective immediately, contingent upon continued funding from the WI Department of Justice VOCA grant, 24 25 BE IT FURTHER RESOLVED that \$70,771 is set up as additional revenue in District 26 Attorney, Victim Witness Program, Critical Incident Revenue, (DAVICWIT 80360) and be 27 credited to the General Fund: and 28 29 30 **BE IT FURTHER RESOLVED** that \$70,771 is transferred from the General Fund to the following expenditure accounts: 31 32 Salaries (DAVICWIT 10009) \$39.731 33 34 Retirement (DAVICWIT 10099) \$ 3.100 Social Security (DAVICWIT 10108) \$ 3,040 35 Health (DAVICWIT 10117) \$12.856 36 37 Dental (DAVICWIT 10153) \$1,139 Supplies & Oper.
