Policy Analysis Statement:

Brief Description of Proposal -

Request approval to accept grant funds to purchase protective communication equipment for use by the Tactical Response Team (TRT)) in a wide range of field scenarios including high risk warrant service, barricaded individuals, dignitary protection, fugitive apprehension, and hostage rescue.

Current Policy or Practice -

Acceptance of grants requires approval of the County Board.

Impact of Adopting Proposal -

The Dane County Sheriff's Office TRT requires protective communication equipment to safely intervene in high-risk events and to safely resolve these situations with no injury or death to Team members. TRT duties include hostage rescue, VIP protection details, resolving high risk situations, and providing assistance on arrest and search warrants.
