AUTHORIZING ACCEPTANCE OF A MAC ARTHUR FOUNDATION GRANT FOR THE COMMUNITY RESTORATIVE COURT

## **Policy Analysis Statement:**

Brief Description of Proposal -

The Dane County Department of Human Services has been awarded a \$50,000 grant from the John D. and Catherine T. MacArthur Foundation. Dane County's innovation will focus on training of local peacemakers and technical advances to support expansion of the Community Restorative Court from the pilot project stage to a county-wide initiative, with the goal of reducing disparities in the criminal justice system.

Current Policy or Practice -

While the 2017 budget expanded the Community Restorative Court pilot program to a county-wide initiative, no funds were included to support this expansion. The County Board added a social worker position, but other needs remain.

Impact of Adopting Proposal -

These funds allow Dane County to support an expanded Community Restorative Court in terms of training peacemakers and addressing data requirements. Becoming part of the MacArthur Foundation's initiative will open the door to national criminal justice system innovation.
