APPROVAL OF ASSIGNMENT OF LEASE NO. DCRA 83-15 INVOLVING LAND AT DANE COUNTY REGIONAL AIRPORT

Policy Analysis Statement:

Brief Description of Proposal -
Old National Bank is requesting Dane County's approval of an assignment of Dane County Lease No. 83-15 from AnchorBank, fsb. Old National Bank recently acquired the assets of AnchorBank, including title to the office building located adjacent to the Dane County Regional Airport at 2719 International Lane, and AnchorBank's interests as lessee under Dane County Lease No. 83-15 involving the land on which the office building is located. This request for transfer is required and provided for under the lease.

Current Policy or Practice -
AnchorBank, fsb, leases land and owns an office building adjacent to the Dane County Regional Airport at 2719 International Lane under Dane County Lease No. 83-15. Dane County approves reasonable requests for lease assignments when the present lessee is not in default.

Impact of Adopting Proposal -
Lease DCRA 83-15 is assigned to Old National Bank and becomes financially obligated to make payments to Dane County. Under this assignment, the terms and conditions set forth in the lease remain unchanged, including the expiration date of November 30, 2082.
