Brief Description of Proposal -

The Laura and John Arnold Foundation will support an intermittently employed, highly-skilled LTE position in the County Board Office to work closely with Harvard University and criminal justice system officials on the evaluation of the impact of the PSA over time. In addition to providing Dane County with \$6,000 for office set up, the LJAF will reimburse Dane County quarterly for the cost of the LTE position for up to \$194,000 over the course of the study.
