Policy Analysis Statement:

Brief Description of Proposal -

The resolution extends the designation of the WI Secretary of Transportation to act as project administrator for the identified types of potential projects to maintain, develop and improve the airport. In accordance with Wisconsin statutes the Secretary acquires funding on behalf of the airport from Federal and/or State sources covering up to 95% of project costs. Sponsor (airport) funding of matching shares continues at the discretion of the Dane County Board during the annual budget approval process. The petition is periodically updated as evidenced by this resolution.
