Policy Analysis Statement:

Brief Description of Proposal -

Dane County Department of Human Services is involved in a program of providing more localized services in the communities identified as needing those services most. Two such programs are the Joining Forces for Families (JFF) Program and the Early Childhood Initiative (ECI). The programs are renewing a lease on office space in a building at 5810 Russett Rd. owned by Rey Anthony Clark and Lora Garrett. The space, Apts. #1, #2, #3, will cost \$28,800 at \$2,400 per month from 1/1/18 to 12/31/18, includes all utilities except electric, and gas for hot water. Adequate funds are budgeted for lease payments and electric and gas costs.

Current Policy or Practice -

Leases require County Board approval.

Impact of Adopting Proposal -

Authorizes the County Executive and County Clerk to execute a lease for space for the JFF and ECI Programs in a building at 5810 Russett Rd. owned by Rey Anthony Clark and Lora Garrett. The space, Apts. #1, #2, #3, will cost \$28,800 at \$2,400 per month from 1/1/18 to 12/31/18, includes all utilities except electric, and gas for hot water.
