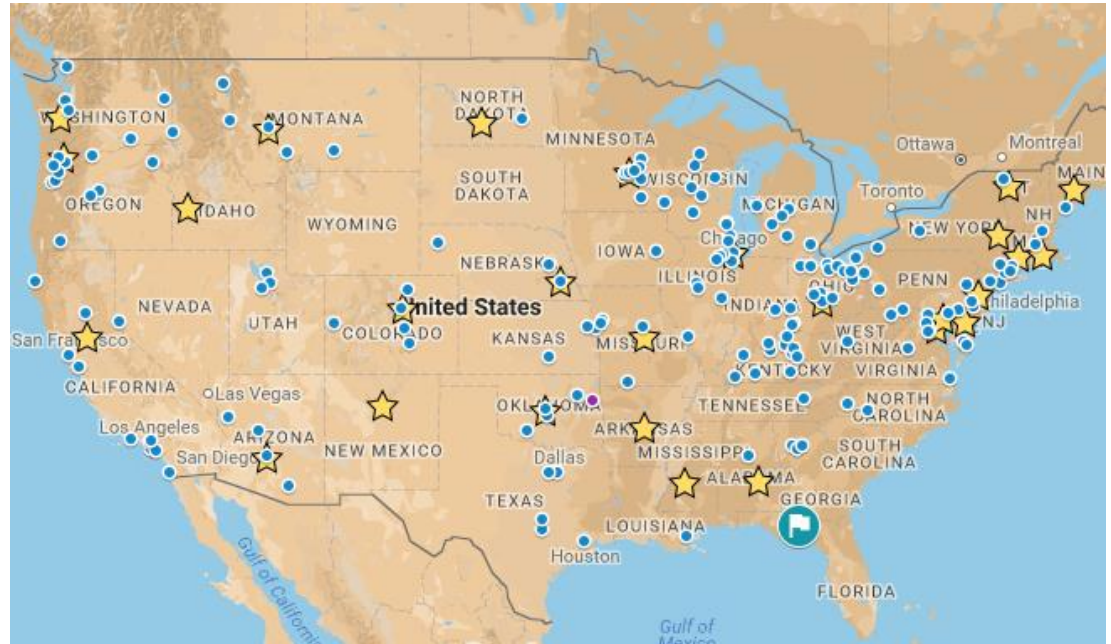
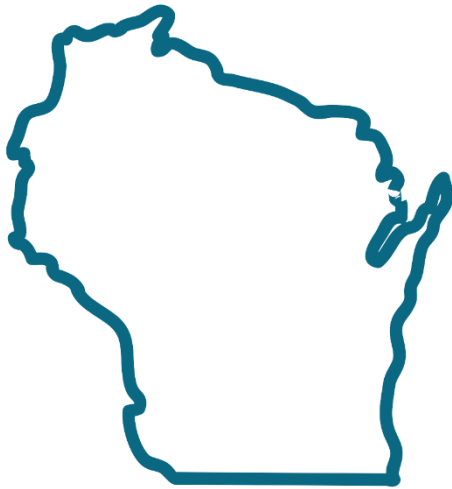


WHAT IS ACCREDITATION?

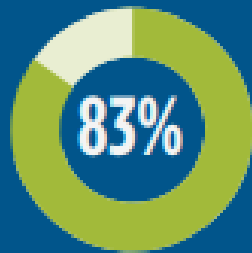


BENEFITS OF ACCREDITATION

- Improves accountability and credibility (internal and external)
- Enhances capacity to deliver core functions and essential services
- Identifies strengths and exposes areas for improvement
- Strengthens internal and external partnerships
- Increases competitiveness for funding



THE VALUE OF PHAB ACCREDITATION



Accountability

The percentage of respondents who said accreditation improves accountability to external stakeholders.¹

"By far the best [outcome of accreditation] is the validation for staff. They are really proud of accomplishing accreditation, and really proud of doing things the right way."²

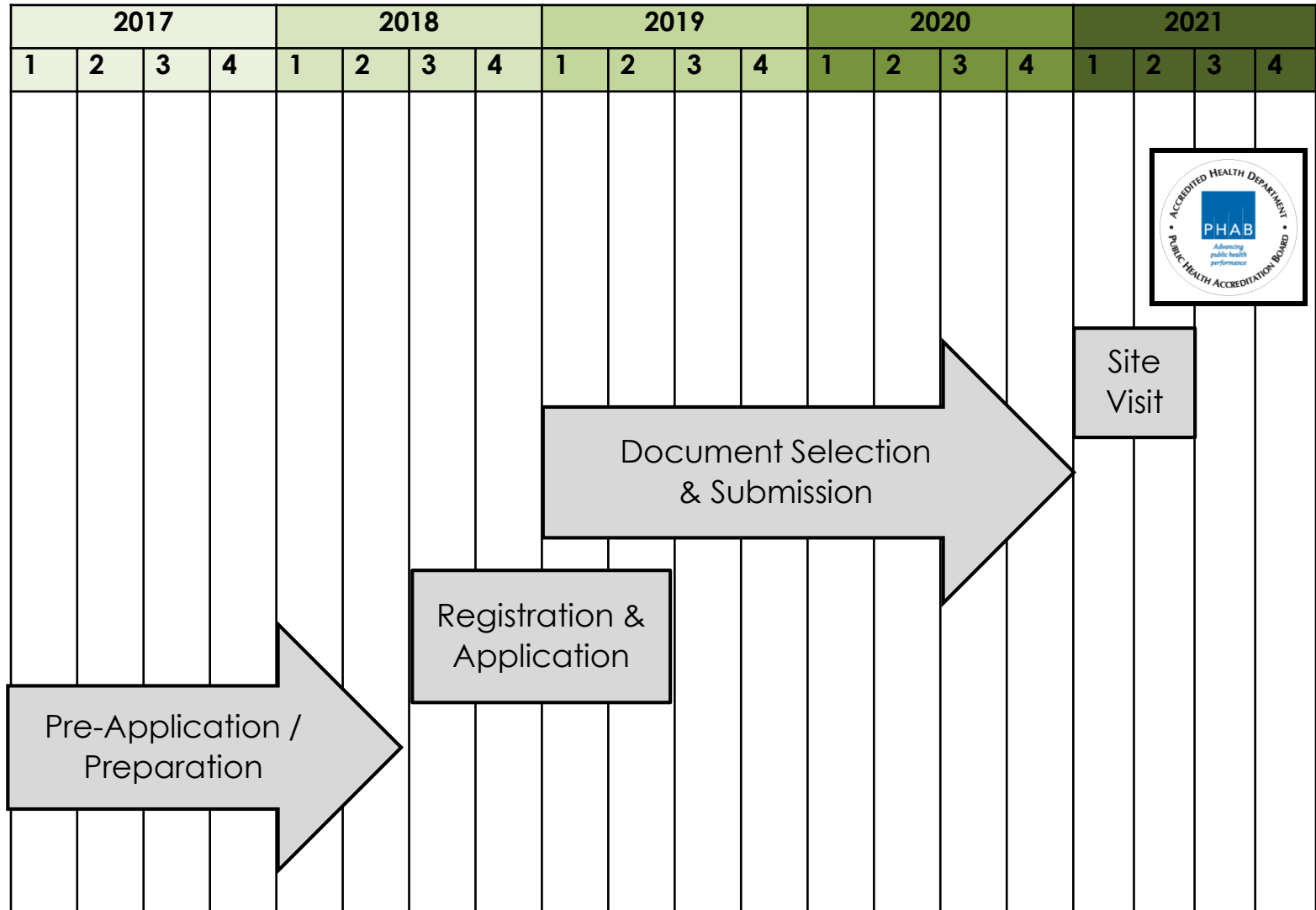


Resources

FEE STRUCTURE

CATEGORY 3 HEALTH DEPARTMENT

Population 500,000 - 1,000,000

Initial Accreditation Review Fee	\$28,000
Annual Accreditation Services Fee	\$11,200



RESPONSIBILITIES OF A LOCAL GOVERNING ENTITY

- Provide point of accountability for the health department
- Advise, advocate, or consult in policy making, priority setting, resource allocation, collaboration, quality improvement, and/or governing
- Directly and indirectly influence the direction of the health department.
- Maintain a working knowledge of roles and responsibilities of the health department.
- Maintain a working knowledge of the roles and responsibilities of the governing entity and its working relationship with the health department.





ROLE OF THE BOARD OF HEALTH IN ACCREDITATION

- Regular communication
- Budget for accreditation costs
- Review PHAB guidance
- Letter of support
- Domain 12 Standards
