2017 ROUND 1

[PUBLIC HEALTH: LED LIGHTING RETROFIT AT PARK STREET, SOUTH AND EAST MADISON CLINIC SPACES (UP TO \$14,076) **NOTE:** THIS PROJECT WAS INITIALLY FUNDED BUT THEN REMOVED DUE TO THE FACT THAT THERE IS A UNIQUE BUDGET ARRANGEMENT BETWEEN THE COUNTY AND CITY FOR PHMDC, WHICH MEANS THAT THE COUNTY CAN'T PUT IN 100% FUNDING TO PAY FOR A CAPITAL EXPENDITURE WHEN THE COUNTY DOES NOT PAY 100% GPR TO SUPPORT THE AGENCY. FOR THIS REASON PHMDC WILL NOT BE ELIGIBLE TO USE THE SMART FUND.]
