AUTHORIZING A POLICE SERVICE CONTRACT WITH THE TOWN OF BURKE

Policy Analysis Statement:

Brief Description of Proposal -

The Town of Burke has requested the Dane County Sheriff's Office provide additional police service within the boundaries of B urke Township, at a level above and beyond the basic level of police service currently provided. The Town of Dunkirk has agreed to compensate Da ne County for the cost of assigning certified sworn law enforcement officers, including necessary equipment and vehicle, to perform law enforce ment service at approximately 12 hours per week. The potential 2018 revenue is estimated at \$50,013.

Current Policy or Practice -

Contracts must be approved by the County Board and executed by the County Executive.

Impact of Adopting Proposal -

Providing law enforcement service to a community is an essential service that is costly, especially for small municipal governments. Purchasing policing service is less costly when compared to the cost of operating a municipal police department or establishing a new police department. The Dane County Sheriff's Office can provide a high level of cost effective service and policing efficiency to the community.
