To whom it may concern:

My name is Ashley, and I am an employee, a parent, and also a household member at one of our Bright Beginnings Day School (BBDS) locations. I have been working at BBDS for 8 years now! I started when I was a pregnant with my oldest kiddo who is now 7 1/2, as a float assistant teacher between the two locations that BBDS had at the time. I was in that position for about 4 months, when I was given the opportunity to be a lead teacher at a new site that we were opening. In January of 2014 we opened our bb2 location, and that is where I started as a lead teacher with my 6 week old son attending at that location. Since that time I have been with Sarah and BBDS through opening 2 more locations as we continue to grow as BBDS, the families in our BBDS community continue to grow and add siblings, and as families are in need of quality childcare for their kiddos. Daycare has always been hard to find in the Madison area, as so many working families depend on us while they are at work to support their families.

Myself and my family, lived in our bb2 location for 5 years, and then two years ago we moved into the location where we live now, as my own family grew and we needed more space. I was on the floor fulltime as a lead at bb2 from January 2014- July 2018 when we had our third kiddo. Once I had her, it didn't make sense to have three out of eight spaces be my own kiddos, so I was given the opportunity to change roles and yet still be a huge part of bb2 and all of our locations. I now co-lead at bb2, fill in at other sites as needed and have more of an administrative role. I love that I am still very involved in BBDS, but that I also get to be with my kiddos, which little did I know that that would have been so needed this last year with the pandemic and having to do virtual school with my boys. We have been so blessed to live where I work. I love that I get to see the kiddos and our teachers everyday, I love building those connections with the kiddos and their families and they get to see as not just teacher but also a mom. We do really just blend into the neighborhood as a single family residence, and some people are not even aware that there is a daycare here. We take pride in our space both inside and out, and we maintain our house and yard for the daycare kiddos and their families, but also to be good neighbors and keep the neighborhood looking beautiful. As a family, we also are getting to know more of our neighbors, build relationships with them, help them if they need anything, and it has been great watching my kiddos run around with the other neighborhood kiddos just as I did when I was little.

As a parent of kiddos who attend BBDS, I have been so happy and couldn't imagine them growing up anywhere else! They have built friendships with kiddos that they grew up with at school from babies until they moved on to kindergarten. We still get together with those families, have playdates and when we do, it is like the kiddos never skipped a beat, you would think they see one and other every day! Even relationships that they have built with current teachers, and past teachers, my kiddos love them as if they were family, and look up to them! As a mom, I never have to worry about my kiddos while they are at one of our locations. I never wonder if they feel safe, loved, if they are happy, if they are having fun, if they are clean, if they are learning and not just curriculum based learning but also learning how to be good, kind, loving, honest, accountable, confident strong little humans. I am forever grateful for their time at BBDS and the opportunities that have been given while in care!

Now you may think that I am biased in my love for BBDS and the care my kiddos receive being that I am an employee, but I do not see it this way. I see and know the behind the scenes, the ins and outs so to speak of BBDS being that I am an employee. Everyday I get to see the passion, the drive, the excitement, the connection, the motivation, and the love that all of our teachers have for our kiddos and

their families. I also know how much time and effort we all put in each and everyday, the planning/prepping of activities and lesson plans, the intentionality behind all that we do and say, the cleaning, sanitizing, the pride we have in making our spaces bright, safe, loving and fun while giving them that home away from home feel! We do this to make sure we are giving the kiddos the best care that we can. We are so much more than "daycare." We strive to be the best, not to give ourselves a pat on the back but because that is what these kiddos deserve. Birth until age 5 is such a vital time in their lives, they are learning new things each day. They are growing physically, mentally, socially, and emotionally, they are learning basic life skills, learning how to be independent, how to problem solve, how to be confident, how to be kind and accepting of others, learning how to conversate with their teachers, their peers, and even our littlest littles who don't have words. It amazes me and it warms my heart to hear one of our 3 year olds talk to one of our infants that's crying because they may be hungry or tired, and the 3 three year old knows how important it is that we acknowledge that their little friend is sad, and they know that we need to talk through that with them and they tell them "it's ok, we know you are hungry, Miss Ashley is making your bottle, and she will give you some snuggles soon." If someone is having a tough morning or scrapes their knee, their friends are always there to comfort them, rub their back, give them a hug, ask them if they need anything, sing them a song, tell a joke, (which may not really be a joke but to them it is) really just be there for their buddies and have that camaraderie with them. There is so much negativity and hate in this world today, and honestly, it scares me what my kiddos and our BBDS kiddos are going to face as they get older but in the time that we have with them, we want to help teach them how to bring light, happiness and kindness to the world! As teachers we are here to build each other up, support one and other, and motivate each other to continue to grow as teachers, but also as good, kind humans and that's what we want to model for our kiddos.

At the core of all of this is Sarah! BBDS has grown so much in the time that I have been here and not just the addition of new sites, but our program as a whole. Her vision, passion for teaching, support, guidance, her drive to always continue to learn more and to push ourselves to be the best version of us that we can be in all aspects of our lives, her ability to look at a difficult situation and turn it into an opportunity of reflection, learning and growth, her appreciation of each of us as individuals and as a team is so important. I have known Sarah and have been apart of BBDS for almost a quarter of my life. In my time here, I have become a mom to three kiddos Oliver, Theodore, and Renesme and more recently a dog momma to our 6 month doodle Nash, I have grown into really being an adult, I have grown in my personal life but also have grown as a teacher as well. Sarah inspires me everyday and if it wasn't for her and the environment she has created at BBDS for the teachers, kiddos and their families I don't know that I would be here 8 years later. As rewarding as working with kiddos is, it is a lot of hard work, especially having young children of my own but I so strongly believe in what we do and see the importance of having quality in-home family childcare, with a mixed age group of eight kiddos and two teachers in a home! Kiddos are in an institutional setting for 13+ years of their lives, they shouldn't be pushed into that setting as an infant, they should be in a home setting with family. My hope is that our new neighbors can be open minded, and see what an asset we our to the community, the voice we can be for these kiddos and the support their families need, as a place for their kiddos to come to each day, to be loved unconditionally, well cared for and safe while they are at work! Also give us the opportunity to show them who we are, what we stand for, our "why" behind it all and our high expectations and the level respect we have for our space inside and outside, all while offering the highest level of quality care.
