## RM-16 to FP-1

That part of Lot 2 of Certified Survey Map 12214 (Vol. 75, Pages 241-243) in the Northeast 1/4 of the Northwest 1/4 and the Northwest and Southwest 1/4s of the Northeast 1/4 of Section 6, Town 5 North, Range 9 East, Town of Oregon, Dane County, Wisconsin, bounded and described as follows: Commencing at the North 1/4 corner of said Section 6; thence S89°38′19″E, 18.50′ to the South 1/4 corner of Section 31, Town 6 North, Range 9 East; thence S89°30′51″E along the North line of Section 6, 639.79′; thence S04°44′55″W, 40.11′ to the point of beginning; thence S04°44′55″W, 1337.23′; thence N87°37′06″W, 235.97′; thence N87°33′53″W, 280.62′; thence N00°53′00″W, 108.59; thence N28°26′00″W, 136.54′; thence N03°41′48″E, 750.06′; thence S89°28′18″E, 220.61′; thence N04°27′18″E, 339.91′ to the Southerly right of way line of Purcell Road; thence S89°33′16″E along said right of way line, 398.17′ to the point of beginning; subject to any and all easements of record.

## **CONDITIONAL ZONING**

Conditional zoning is hereby imposed pursuant to Section 10.101(8)(d) of the Dane County Code of Ordinances. The rezoned area shall be subject to the following conditions.

## CERTIFIED SURVEY REQUIRED

The above listed description/s is/are intended to describe land for which a certified survey map will be prepared for approval and recorded. Within 90 days of rezoning approval by Dane County, a *final* certified survey map that describes the land to be rezoned shall be prepared in accordance with all applicable provisions of Chapter 236 Wisconsin Statutes and Chapter 75 Dane County Code of Ordinances, and submitted to the Dane County Zoning Division. Upon submission of the final certified survey map, the Zoning and Land Regulation Committee, or its authorized representative, shall, within 30 days, approve, approve conditionally, or reject the certified survey map. Failure to submit the final certified survey within the 90 day period <u>and/or</u> failure to record the survey with the Dane County Register

of Deeds will cause the rezone to be null and void. Two copies of the recorded survey shall be submitted to Dane County Zoning.
