## 1. City and County Outreach to the Homeless at CCB

Casey Becker and Sue Wallinger presented on the outreach that has been done for the homeless at the CCB. Workers reported that some housing placement has ocurred due to outreach. They have opened intake days at Journey Mental Health, caseworkers indicated a need for a wet shelter. A very small number of people do not want services at all, others want to make changes.

Matano asked about where the people who stay at the CCB come from; the response was that the population size changes based on waht day of the month it is because resources run out at different times of the month.

Ragland questioned if there are services available for the people that stay at the CCB; the response was that there are lot of services for homeless.

Baldeh asked if they could guarantee that there is a place for everyone to go; the response was that no, they cannot, it's a very transient population. Currently the single men's shelter has 50-80 men at shelter at night, and the women's shelter has a capacity of 30, but when the conditions are bad in winter they take everyone.

Carter inquired if there are any providers considering having a wet shelter; the response was that not to their knoweledge, no.

Ragland inquired if they are aware of how other counties/cities/towns handle homeless, and wondered if it is good to be homeless in Madison; the response was that is a judgement call.

Supervisor Wegleitner spoke:

City County Homeless Issues Committee is up and running and meeting regularly, hopeful that they will continue to make progress on these issues. Stakeholders, elected officials need to come together to make progress.
