## 2. DISCUSSION AND POSSIBLE COMMITTEE ACTION ON 2016 PROGRAM EVALUATION AND STUDY TOPICS

*Chair Corrigan also indicated that a likely County Board program review topic for future committee consideration would be a study of best practices for vocational training in the Dane County jail (for possible funding through the County Board Office audit line).*

**A motion was made by CORRIGAN, seconded by BAYRD, that the following be recommended for approval: "Allocate \$4,800 from the County Board Office audit line to be used for a consultant to facilitate a workgroup to review all current adult and juvenile diversion programs and criteria for admission and successful completion, and to develop an equitable framework to ensure access to existing diversion programs. The workgroup should identify barriers to enrollment in and successful completion of the programs and make recommendations for improvements. The workgroup should develop a list of large, traditional organizations and smaller, neighborhood-specific grassroots entities that can offer services to benefit the clients enrolled and contribute to the improvement of communities and diverse populations within them. The consultant will be selected with input of the chairs of HHN and PP&J committees. The workgroup will include up to 11 appointments made jointly by the chairs of HHN and PP&J after receiving input from the Presiding Judge, District Attorney, Clerk of Courts, Sheriff, County Board members, POS agencies, and the Director of the Department of Human Services. The workgroup will provide per diems for members and will be limited to five meetings. Appointments to the workgroup will be made by 1/15/16 and the study completed by 7/1/16 to allow a recommendation for the 2017 budget. "**
