3. FALL LISTENING SESSION

Batterman's attempt to facilitate a Committee listening session in conjunction with the Sunshine Supper in Sun Prairie was unsuccessful. A discussion entitled "Addressing the Needs of African American Aging Adults" on 14 November at Mt. Zion Baptist Church in Madison will focus on what must to be done to meet the current and future needs of African American seniors. AAA Aging Program Specialist Angela Velasquez suggested that because African Americans are under-represented among consumers served by AAA programs, the discussion could prove effective in meeting the goal of soliciting feedback from seniors who do not access Dane County services. Committee Members agreed the discussion is a good option. Batterman encouraged Committee Members to attend and will provide the details. AAA is one of the sponsors of this community event.

4. CHAIR & STAFF REPORTS

Velasquez reported work continues on the 18-month Dementia Crisis Response Grant, including recent completion of a form to be displayed prominently in homes to provide law enforcement and first-responders information about how individuals in distress should be safely approached.

Velasquez reported Dane County will cease funding Home-Delivered Meals (HDM) seven days per week effective 31 December 2017. HDM will be reduced to meet the federally-mandated five days per week requirement beginning 2018.

Batterman reported Dane County's Health and Human Needs Committee (H&HN) passed an amendment for an increase of \$50,000 in Case Management funding in the 2018 AAA Budget, to be distributed via the funding formula. The AAA Board had endorsed awarding the entire amount to South Madison Coalition of the Elderly (SMCE) to hire a Case Manager to address a lengthy waitlist. H&HN did not pass the \$10,000 Cultural Diversity Transportation (CDT) amendment. AAA Board Chair Bill Clausius, who serves on Dane County's Personnel and Finance Committee (P&F), plans to introduce an amendment for discussion at that Body's meeting on 8 November. AAA Board Member Patrick Downing, also a Dane County Supervisor, is a co-sponsor of the CDT amendment.

Batterman reported the anticipated October launch of a shared-resource data base for Case Managers was delayed due to a technical glitch that is being addressed.
