### D. Presentations

1. Work-N-Wheels Program

Jeff Segebrecht SWCAP gave a brief overview of the Work-N-Wheels program. Car loan eligibility is based on income and ability to get to and from work. Dane County has 24 residents with interest free car loans. Loan repayment is current on 83% of the outstanding loans. Typical car payments are \$150.00 - \$175.00 per month based on participants ability to pay. 2. Legislative Day

Betzig gave a recap of the Transportation Legislative Day held at the State Capitol on March 8, 2017.

Legislative issues include: creating a State Transit Capital Investment Program with VW settlement money; eliminating cuts to the Transit Operating Assistance Program; holding the Transportation budget harmless for the addition of New Shared-Ride Taxi Systems; insuring that Volunteer Drivers are not subject to increased personal car insurance cost; insisting Non-Emergency Medical Transportation, MTM, meets their obligation to continue a Transportation Advisory Committee with appropriate statewide representation and hire a third party external advocate to represent customers; supporting the Coordinating Council on Access and Mobility and increasing the Charitable Mileage Reimbursement Rate.

> The Mobility Management Call Center authorized 33,060 rides. 2016 rides are slightly less that 2015, most likely due to staffing shortages at the call center. Total rides authorized in 2016 were 277,129.

Senn noted that the RFP for MCOs under Family Care was cancelled earlier this month and two new RFPs were released. Metro plans to negotiate with family care regarding funding and fares for paratransit use.

### Zutter RSPV

Zutter discussed potential funding deficits for the 2018 budget. She also noted the RSVP drivers receive mileage reimbursement at the IRS rate.

#### **Betzig – Dane County Human Services**

The AAA Legislative/Advocacy Committee supports increasing Transportation at the Focal Points. Congress introduced a bill to repeal the 50 year old assurance of non-emergency medical transportation(NEMT) for Medicaid patients which includes the aged, blind, disabled and other medically frail individuals.
