Director Fraire recommends discussing an additional grant fund request from the County Executive in 2023 for the 2024 budget

A motion was made by Commissioner Miquelon to approve a maximum budget of \$70,000 during the 2022-2 Grant Cycle, seconded by Commissioner Puleo Moyer.
