Low Mow May: The 5.19.22 Dane County Board agenda includes an honorary resolution to recognize May 2022 as Low Mow May and to promote pollinator friendly lawn height year-round. This resolution is in line with the City of Madison resolution, and is designed to boost the population of bees and other pollinators. Members of both food councils were instrumental in developing this resolution (Supervisor Ritt, Laura Scandurra) in conjunction with city and county staff.

- Community Gardens Nicholas Leete Community gardens are finishing up registration. There are still some openings in case folks can help get the word out.
