A motion was made by Commissioner Puleo Moyer to approve the March 16, 2022, Arts and Cultural Affairs Commission meeting minutes, seconded by Vice Chair Morgan.

The motion was carried by a unanimous voice vote.

C. Action Items

- Chair Ritcherson stated that this meeting will be focused only on the grant application review process and the allocation of grant awards. Reports to committees and other normal business will resume at the next monthly meeting.
- A note on the grant process: Grants are reviewed by Dane Arts staff first, then reviewed and scored by panels, scores are reviewed by the Executive Committee for recommendation for approval by the full Commission, then approved by full Commission.

1. Grant allocation cut off level, Minimum grant award allocation

- A minimum grant award for all eligible applications was previously discussed by the full Commission and Executive Committee
- The Executive Committee recommends a minimum grant award of \$500 for the 2022 Cycle 1 applications
- Vice Chair Morgan pointed out that in past cycles, there was a larger gap between the lowest scoring grants, but in 2022 Cycle 1 there was no such gap, and all applications were deemed eligible

A motion was made by Commissioner Curet to award a minimum of \$500 to every eligible grant applicant in 2022 Cycle 1, seconded by Vice Chair Morgan.

The motion was carried unanimously by a voice vote.

2. Final review/approval of cycle one grant award allocations

- According to Dane Arts policy, if a commissioner has a potential conflict of interest within a grant application, they must recuse themselves from voting on the grant award during the given cycle
- In 2022 Cycle 1, Commissioner Miquelon will recuse herself due to a potential conflict of interest as a sub-recipient of application #23605 (Madison Children's Museum)
- A new mathematical formula developed by Commissioner Curet will be applied to the allocation of 2022 Cycle 1 funds, and grant allocation amounts will directly correspond with applicants' scores
- A minimum award assures eligible lower scoring applicants still receive funds of at least \$500, if warranted.

A motion was made by Commissioner Klehr to approve the proposed grant allocations totaling \$95,399 among the 59 2022 Cycle 1 applicants, seconded by Commissioner Parks Snider.

The motion was carried unanimously by a voice vote.

3. Approve two selected Dane County sponsored artists for EUARCA+ 2022

- Dane Arts is supporting the County Board of Supervisors' relationship with sister County, Kassel, in Germany by selecting two artists to represent Dane County during EUARCA+ 2022 (European Art Camp), August 7 22
- 17 applications were received and two artists, Angelica Contreras and Helen Hawley, were selected as ambassadors to represent Dane County

A motion was made by Vice Chair Morgan to approve the selections of Angelica Contreras and Helen Hawley, seconded by Commissioner Klehr.

The motion was carried unanimously by a voice vote.
