AMENDING CHAPTER 46 OF THE DANE COUNTY CODE OF ORDINANCES,
REGARDING PUBLIC HEALTH LICENSE FEES

The County Board of Supervisors of the County of Dane does ordain as follows:

ARTICLE 1. Unless otherwise expressly stated herein, all references to section and chapter numbers are to those of the Dane County Code of Ordinances.

ARTICLE 2. Section 46.015 is amended to read as follows:

46.015 AUTHORITY. This ordinance is enacted under the authority of sections 59.70(1), 59.70(5), and chapters 97, 101, 145, 250 through 254 and 281, Wis. Stats., and provisions of the Wisconsin Administrative Code adopted pursuant thereto.

ARTICLE 3. Section 46.34 is amended to read as follows:

46.34 COUNTY FEES. ~~(1) Public Health Department license fees shall be determined by the Board of Health. County fees for permits required by s. 46.33 shall be established by the County Board and published in the Public Health Madison and Dane County Fee Schedule, which shall be publicly available at the County Clerk’s Office and posted on the Department’s website. The following shall be the county fees for the various permits authorized under section 46.33:~~

48 ~~1. A micro market is an unstaffed, self-checkout retail food establishment~~
49 ~~selling prepackaged time and temperature controlled food located within a~~
50 ~~business.~~

51 ~~2. No person, firm, or corporation shall operate a micro market without~~
52 ~~possessing a food and drink permit in good standing. The permit shall be posted~~
53 ~~in a conspicuous place in the premises named in the permit. Only a person who~~
54 ~~complies with the requirements of this ordinance shall be entitled to receive~~
55 ~~and/or retain a permit.~~

56 ~~3. The annual fee for the micro market permit shall be forty (\$40) for one micro~~
57 ~~market located in a building, and shall be sixty dollars (\$60) for two or more micro~~
58 ~~markets located in the same building. The licensing year shall be from July 1~~
59 ~~through the following June 30. The permit fee herein established shall be for one~~
60 ~~year or a fractional part thereof. Renewal licenses shall be obtained on or before~~
61 ~~June 30 of each year or be subject to a late filing fee of fifteen percent (15%) of~~
62 ~~the license fee. Payment of the late filing fee shall not relieve any person from~~
63 ~~any other penalties prescribed in this chapter for failure to possess or obtain a~~

67 ~~(f) Notwithstanding this subsection, there shall be no county fee for temporary~~
68 ~~food establishment operations, as defined in section ATCP 75.103(5)(h) of the~~

70 ~~patriotic organizations; service clubs and civic organizations that occasionally~~
71 ~~prepare, serve, or sell meals to transients or to the general public. Occasional~~

73 ~~(g) Review and Inspection.~~

74 **(a) 1.** Inspection. Public Health Madison and Dane County may charge a State
75 of Wisconsin licensed operator or entity an inspection fee of \$25 per day.

76 **(b) 2.** Reinspection. If Public Health Madison and Dane County reinspects a
77 regulated business because Public Health Madison and Dane County finds a
78 violation of this Chapter, Public Health Madison and Dane County shall charge
79 the operator a reinspection fee. The reinspection fee for the food and drink
80 permit shall be based upon the anticipated gross annual food and drink sales for
81 the licensing year as set forth in the table below. The reinspection fee for a hotel,
82 motel, tourist rooming house, bed and breakfast establishment permit; a public
83 swimming pool permit; or a recreational, educational camp, mobile home park or
84 campground permit shall be \$150 for the first reinspection and \$250 for
85 subsequent reinspections. There is no reinspection fee for micromarkets. A
86 reinspection fee is payable when the reinspection is completed, and is due upon
87 written demand from Public Health Madison and Dane County.

90 **(c) 3.** Plan Review Requirement and Fee. Public Health Madison and Dane
91 County shall require an operator of a new or extensively remodeled food
92 establishment to submit equipment layout plans, equipment schedules, detailed
93 descriptions of food processing operations, and menus for review as requested.
94 Public Health Madison and Dane County shall charge the establishment owner or
95 operator of a new food establishment the plan review fee based upon the
96 anticipated gross annual food and drink sales for the licensing year as set forth in
97 the table below. The plan review fee for a new hotel, motel, tourist rooming
98 house, bed and breakfast establishment permit; a public swimming pool permit or
99 a recreational, educational camp, mobile home park or campground permit shall

100 be \$375 and \$250 for an existing establishment that will be extensively
 101 remodeled. Micromarkets are exempt from plan review fees.

 104 ~~(d)4.~~ Fees for Special Conditions Inspections. Public Health Madison and Dane
 105 County may charge for any inspection or consultation services that are not
 106 directly related to Public Health Madison and Dane County’s permitting and
 107 licensing responsibilities. Public Health Madison and Dane County may charge
 108 the operator or owner of an entity requesting the inspection or consultation a fee
 109 of \$250.

110 ~~(e)5.~~ Fees for Hazard Analysis and Critical Control Point (“HACCP”) Plan
 111 Review. Public Health Madison and Dane County may charge a fee of \$100 for
 112 any HACCP plan review or subsequent annual verification to the operator or
 113 entity required by law to submit an HACCP plan for approval. A separate
 114 HACCP plan review fee shall be paid for each HACCP plan.

 119 Wisconsin Statutes, the fee for a pre-inspection shall be based upon the
 120 anticipated gross annual food and drink sales for the licensing year as set forth in
 121 the table in 46.34(6)(g)3. A separate pre-inspection fee shall be paid for each
 122 category of permit or license. The pre-inspection fee for food and drink
 123 establishments that are primarily retail and do not engage in food processing
 124 shall be \$100 for each pre-inspection. The pre-inspection fee for a hotel, motel,
 125 tourist rooming house, bed and breakfast establishment permit; a public
 126 swimming pool permit; or a recreational, educational camp, mobile home park or
 127 campground permit shall be \$375. Micromarkets are exempt from pre-inspection
 128 fees.

130 requiring a food and drink license; a hotel, motel, tourist rooming house, bed and
131 breakfast establishment license; a public swimming pool license; or recreational,
132 educational camp or campground license; a tattooing and body piercing license,
133 found to be operating without a license, shall pay to the department a forfeiture of
134 \$250.00, in addition to applicable fees.

‡35 ~~(4)(12)~~ *Fee for operating without a Wisconsin certified food manager.* The
136 department shall charge the operator of a restaurant a forfeiture of \$150.00 for
137 operating without a Wisconsin certified food manager.
