Provide a detailed description of the goods/services intended to be purchased:

The county purchases from Vivent Health (formerly known as AIDS Resource Center of Wisconsin) which partially funds three case manager positions to provide intake, assessment, and prevention services for individuals with a high degree of risk of spreading sexually transmitted infections(STI) and for risk reduction services to individuals with HIV. Vivent works jointly with the community health professionals in a) identifying individuals suspected of STIs and HIV infection, b) coordination of testing and treatment services, c) risk reduction education sessions, d) linking at risk individuals with physicians and medical care providers e) STI treatment medications. Additionally, the project strengthens linkages with the city and county public health testing and partner notification services for the purposes of data collection, community needs assessment, planning and evaluation.

The County started purchasing services from the AIDS Network in the mid-1980's when they were selected by the State of Wisconsin as the designated AIDS Service Organization for Dane County.

Provide a detailed explanation as to why the competitive bidding (RFB/RFP) process cannot be used. Also provide a detailed justification in relation to the Procurement Exception(s) chosen:

The State of Wisconsin Department of Health Services divided the state into five regional areas for the provision of AIDS related services. Vivent (formerly known as AIDS Resource Center of Wisconsin) is the designated provider for the Southern region, which includes Dane County, Janesville and Beloit. Each of the designated agencies provides a prescribed set of services, including medical referral, legal advocacy and health education. Dane County purchases intake, assessment and case management services from Vivent, which complements the State's basic support package. Vivent is uniquely positioned in our community to offer comprehensive harm reduction services to Dane County residents. It has a very strong presence as the State's designated service agency. Citizens and professionals routinely contact Vivent when they need services or technical advice. If another agency were selected as a result of the RFP process, it would diminish the impact of the funds, in that they would no longer be paired with the DHS services offered by Vivent. It would also cause great confusion among consumers and community members. This would result in duplication and fragmentation of services.
