Supervisor Weigand asked when in-person meetings would begin, and Chair Andrae stated that she anticipated it would occur after mid-June.

Supervisor Weigand asked that the following subject matters be explored at a future meeting: (1) the recent act of arson at the Wisconsin Family Action Office; (2) the use of bail in Dane County; (3) human trafficking; (4) car thefts. Supervisor Gray also suggested bail reform as a future topic. Chair Andrae stated that the use of bail has not been addressed recently and may be appropriate for another review. Chair Andrae also asked whether a joint informational meeting with public works and transportation would be helpful for members to understand the jail consolidation project's process. Supervisor Gray proposed that the committee explore the Huber program. Supervisor Kigeysa added the use of weekend court as a topic as well. Supervisor Pellebon suggested adding the CJC's membership as a discussion item.

Chair Andrae proposed moving the time of the committee meetings to 5:30, and no member commented.
