The Zoo is hoping to bring in a new camel soon. We are excited to share that news with the public once the transfer has been finalized. Bison have been hard to find. Zoonotic diseases in other populations are making it challenging. Penguins will be moving out to a different facility in the future until the Zoo can update that exhibit space. We don't have dates for the move yet but are working with AZA. Our AZA site visit last month found no animal welfare concerns. The Zoo's external investigation was going on at the same time that AZA was here and the Zoo made sure to include the judge in those talks with AZA. The external investigation interviews have been completed, we are just waiting for the final report. Discussion ensued.

Ronda and Joseph gave an overview of the Zoo's 2023 requested budget. The total budget is just over 6 million. There are several capital projects included in the budget, the biggest one being the design and development of the Zoo's new giraffe exhibit. The one new line item is for DEAI. This will help us start to implement some of Keen's recommendations from our access and equity survey. The Zoo is aware that this is just a starting point but it is a way for us to show our commitment to DEAI issues moving forward. 2022 was the first year the zoo took over operations of the train and carousel and we are pleased with the revenue it's generating. Events are going well. Discussion ensued.
