AUTHORIZING AN AGREEMENT TO ACCEPT GRANT FUNDING FOR THE PURCHASE OF NIGHT VISION EQUIPMENT

**Policy Analysis Statement:**

Brief Description of Proposal -  
Request approval to accept grant funding for the Sheriff's Office to purchase tactical night vision equipment for use in high risk, low light, situations including search and rescue efforts, and evidence recovery.

Current Policy or Practice -  
Acceptance of grants requires approval of the County Board.

Impact of Adopting Proposal -  
The Dane County Sheriff's Office requires specialized night vision equipment to provide vision enhancement in low light situations. Night vision equipment enhances surveillance capabilities which allows for safer resolution of high risk situations for law enforcement officers and the public.
