Brief Description of Proposal -

Request approval of grant funding for the purchase of rural marksman equipment for use by the Sheriff's Office Tactical Response Team (TRT). Grant funding of \$3,500 shall provide for the purchase of binoculars with integrated range finders.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

Impact of Adopting Proposal -

The Dane County Sheriff's Office TRT requires rural marksman equipment to safely operate in high-risk environments. Binoculars with range finders relay accurate information during critical incidents including search and rescue efforts and to scanning terrain effectively and efficiently. The use of binoculars with integrated range finders improves communication and decision making during intense uncertain and rapidly changing high risk calls for service, enhancing safety for law enforcement officers and the public.
