Policy Analysis Statement:

Brief Description of Proposal -

The Dane County Sheriff's Office participates in a High Intensity Drug Trafficking Area (HIDTA) Program as part of the Milwaukee HIDTA and operates as a member agency for the program. Request authorization to accept grant funding of \$150,000 from the Office of National Drug Control Policy (ONDCP) to support the HIDTA Program.

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

Grant funding from ONDCP provides reimbursement for criminal investigations involving drug trafficking and money laundering activities and provides enhanced intelligence opportunities and greater operational coordination for HIDTA member law enforcement agencies. HIDTA program efforts decrease drug distribution, drug related violent crime, money laundering, and the demand for illegal drugs within the Milwaukee HIDTA region and decreases the distribution of illegal drugs to Wisconsin urban and rural areas.
