The one year lease begins January 1, 2023 and ends December 31, 2023. The negotiated monthly rental rate is $\$ 822.56$ per unit or $\$ 3,290.23$ per month which is $\$ 39,482.76$ annually. The lease includes four (4) additional one year renewal terms at a $4 \%$ increase each year.
