The purchase of a bomb suit is required because it provides hard and soft protection for bomb technicians when dealing directly with hazardous and/or potentially explosive devices. Specifications of bomb suit and associated equipment, to be purchased, is approved by NABSCAB and the FBI. Bomb technicians wear a bomb suit while performing stressful tasks that require fine motor skills. Bomb suits are designed to protect against the characteristics of an explosive event that could result in human injury or death.
