## C. Discussion Items

## Protocols

*Dane County EMS (DCEMS) held two meetings with chiefs over last couple months to discuss next steps for protocol updates. Conversations were had about Dane County Protocols and other protocols being used throughout the county. Focus will be put on the medicine and see if compromise can be found in medication discrepancies. DCEMS will meet with Medical Directors May 5th, talk about differences amongst protocols and any additions that should be included. There will be two meetings with medical directors with agendas. Starting in June, DCEMS office will pull together a work group with members of different agencies and medical direction. Will ask if providers have found any challenges. There will be two town hall meetings where EMS providers can come in person or join virtually to talk about any changes or concerns. DCEMS Office will also send out a survey for anyone to provide feedback or thoughts, which will be open until end of June. At the end of August, medical directors will meet again to approve final product before sending to state.*

## Radio Report

*Had meeting with UW Health in March talking about combining VHF and 800 radios. Were concerned about getting rid of that redundancy so it was agreed to come up with a training plan instead. There is a meeting later this week with just hospital Emergency Department (ED) leadership, and the following week will be meeting with ED staff and EMS personnel interested in being involved. Madison College is also involved. Not enough emphasis has been put on radio reports since county switched to DaneComm; next steps to come.*

## 10 Delta

*Overview of history on 10 Delta Auto ALS Update, specifically chest pain. Shared the data collected from the time period of April 6 2020 - October 6, 2020 for both non-paramedic agencies and paramedic agencies. Three main takeaways: there is opportunity for non-paramedic agencies to send 12-leads to hospital for interpretation; improve 96% capture rate of 12-leads; documentation is sometimes lacking to support vital signs (sometimes vital signs don't match what narrative says). Ask for crews to verify vital signs being pulled. Group is close to finishing paramedic-level review. Hoping to have it complete in the next couple months. No recommendations at this time.*

## Base Hospital

*Had a few out-of-county incidents close to Dane County. Talking about changing the way we put the activation out. No difference for EMS or hospitals, but there's a Dane County template and an out of county template. Going to change to Region 5 template; if it is a Dane County incident 911 would use the same template as with out of county incidents. This will speed up activation. Meier adds we're doing one unannounced and one announced drill every month. Announced drill is done with EMS agency, let DCEMS office know if your agency is interested in participating. Also working with Dan Williams and Jennifer Behnke about getting other regions trained up on Base Hospital.*
