AUTHORIZING GRANT FUNDING FOR SHERIFF'S OFFICE HAZARD DEVICES UNIT (HDU) VEHICLE UPGRADE

Policy Analysis Statement:

Brief Description of Proposal -

Request approval to accept grant funding of \$135,500, from Homeland Security, Wisconsin Department of Military Affairs, for the upgrade of the Sheriff's Office HDU, large response vehicle.

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board. The current vehicle is 17 -years old, nearing the end of its service life, and is no longer functional due to the evolution of techniques, procedures, and technologies used in dealing with hazardous devices.

mpact of Adopting Proposal -

The HDU large response vehicle is used to safely transport HDU operators, supplies, and equipment to hostile environments and is designed to provide cover for team members once they are deployed to defuse explosives. This updgrade would significantly extend the service life of the truck and is a fraction of the cost of replacing it.
