# Policy Analysis Statement:

# Brief Description of Proposal -

The Wisconsin Department of Justice (WDOJ) has awarded the Dane County Narcotics Task Force (DCNTF), COPS Office Anti -Heroin and Anti-Methamphetamine Grants totaling \$15,000; Anti-Heroin Grant \$10,000, Anti-Methamphetamine Grant \$5,000, to be utilized calendar year 2023. This grant funding will support overtime expenses associated with the development and investigation of narcotics cases that t arget the illicit trafficking of heroin/opiates (Anti-Heroin Grant) and the manufacture and/or distribution of methamphetamine (Anti-Methamphetamine Grant).

# Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

#### mpact of Adopting Proposal -

Acceptance of Anti-Heroin and Anti-Methamphetamine grant funding shall advance public safety by providing funds to locate and investigate illicit activities through statewide Task Force collaboration related to the manufacture and/or distribution of methamphetamine and for the distribution of heroin, fentanyl, carfentanil, and the unlawful distribution of prescription opioids.
