RESOLUTION PROVIDING FOR A REFERENDUM
ELECTION ON APRIL 4, 2023 ON THE QUESTION OF THE APPROVAL OF AN
INITIAL RESOLUTION AUTHORIZING THE ISSUANCE OF
GENERAL OBLIGATION BONDS IN AN AMOUNT
NOT TO EXCEED \$13,500,000

WHEREAS, the County Board of Supervisors of Dane County, Wisconsin (the "County"), has heretofore duly adopted a resolution entitled: "Initial Resolution Authorizing General Obligation Bonds in an Amount Not to Exceed \$13,500,000" (the "Initial Resolution") for the public purpose of financing the costs of completing the consolidated jail project that consists of constructing a tower up to 6 stories and renovating the Public Safety Building to include no more than 825 beds; and

WHEREAS, the County Board of Supervisors deems it to be desirable and in the best interest of the County to direct the County Clerk to submit the Initial Resolution to the electors for approval or rejection at the regularly scheduled election to be held on April 4, 2023.

NOW, THEREFORE, BE IT RESOLVED by the County Board of Supervisors of the County as follows:

<u>Section 1. Referendum Election Date</u>. The County Clerk is hereby directed to call a referendum election to be held in the County at the regularly scheduled election to be held on April 4, 2023 for the purpose of submitting to the qualified electors of the County the proposition of whether the Initial Resolution shall be approved.

Section 2. Notice to Electors. The County Clerk is directed to give notice by:

- (a) causing a Notice of Election to be published in the <u>Wisconsin State Journal</u> in the issue published on the fourth Tuesday before the referendum election.
- (b) causing a Notice of Referendum (which includes the facsimile of the sample ballot) to be published in the <u>Wisconsin State Journal</u> in the issue published immediately preceding the referendum election. This Notice shall also be posted in each polling place on election day.

If any of the municipalities within the County use an electronic voting system employing a ballot label and ballot card, the Notice of Referendum shall also include a true, actual-size copy of the ballot label and ballot card in the form in which they will appear on election day.

<u>Section 3. Polling Places and Hours</u>. The County electors must vote at the referendum election at the times and polling places at which they cast their ballots in regularly scheduled elections.

<u>Section 4. Referendum Election Officials</u>. The election officials appointed in each of the municipalities within the County shall conduct the election.

<u>Section 5. Official Referendum Ballot Form</u>. The ballot to be used at the referendum election shall be prepared in accordance with the provisions of Sections 5.64(2) and 7.08(1)(a), Wisconsin Statutes. The ballot shall be substantially in the form attached hereto as Exhibit A.

The County Clerk shall cause to be printed sufficient ballots for use at said referendum election, both as actual ballots in those polling places which do not use voting machines and as absentee ballots where voting machines are used and as specimen ballots (the latter to be of a different and easily identifiable color from the actual ballot). The County Clerk shall file a copy of the ballot, as soon as possible after the date hereof but in no event later than 70 days prior to the election, as provided in Section 8.37, Wisconsin Statutes, with the official or agency responsible for providing the ballots for the election.

<u>Section 6. County Canvass</u>. The returns of the referendum election shall be posted by the County Clerk and canvassed by the County Board of Canvassers pursuant to Section 7.60, Wisconsin Statutes.

EXHIBIT A

Official Referendum Ballot April 4, 2023
