The City of Fitchburg is planning an intersection reconstruction project at Syene/McCoy, that will affect the Capital City Trail and trailhead parking lot. Senior Landscape Architect Chris James presented their three alignment alternatives. He noted that the City of Fitchburg is currently moving forward with Alternative 2. 2. Lower Yahara River Trail / Lake Kegonsa State Park Petition to Railroad
