Policy Analysis Statement:

Brief Description of Proposal -

The Alliant Energy Center has a 1.0 FTE Event Operations Supervisor (M6), position #3352 which is requested be reclassified to a 1.0 FTE Event Coordinator (P8), currently vacant. Additionally, it is requested that the two (2) existing Event Coordinators (P-6), positions #3298 and 3299, be reclassified to Event Coordinator (P-8). The Department of Administration – Employee Relations Division has recommended approval of these requests.

Changes in position classification require County Board approval.
