Dane County is currently in the process of [updating the Dane County Farmland Preservation Plan](#) to meet state recertification requirements. Our goal is to have a revised plan introduced to the county board by September, and to complete recertification of the plan by DATCP by 12/31/2022. The County Zoning and Land Regulations committee has appointed a [Farmland Preservation Plan Steering Committee](#), consisting of staff from municipalities and other county agencies that participate in the Farmland Preservation program.

One of our current members, Wade Thompson of the City of Fitchburg, will be leaving our committee after our May 3 meeting, as he takes a new job with the DNR. We'd like to maintain some representation from incorporated cities and villages that participate in the Farmland Preservation Program.
