2023 Zoo Lights Sponsorships

SCHWETZ gave an animal update. The Zoo is on track to get a new bison in mid-February. We recently got land snails that will be part of our animal ambassadors. The capybaras were moved down to the Animal Health Center for the winter, which gives them more space. The male aldabra tortoise had a bone infection, and to ensure the infection didn't spread he had one toe amputated. The female aldabra was moved in with lemurs so that the male had a quiet space to heal. The lemur exhibit also gives the female more room during the winter months.

Education update - Summer Zoo Camp registration is currently open. Switching to a lottery system instead of first come, first serve for the first time this year. Allows working parents an equal opportunity to get their kids enrolled. Have received very positive feedback on the change. We reserve two spaces in every camp program for scholarship recipients.

DARCANGELO gave a financial update. Zoo Lights made slightly less money than last year, but we had to close for two nights because of weather. Gave updates on event revenue.

MOALA gave an update on 2023 events. Two new events are being planned for June. The Commission was given sponsorship information to share with any potential partners for the zoo run and zoo lights.
